

#### SOFTWARE END USER LICENSE

This Software End User License ("EULA") (this "<u>License</u>") is a binding agreement between Owl Cyber Defense Solutions, LLC, a Maryland limited liability company (referred to herein as "Owl Cyber Defense" or "<u>Licensor</u>") and the person or entity identified on the Order Form, or a License Transfer Document as the end user of the Software ("<u>End User</u>").

LICENSOR PROVIDES THE SOFTWARE SOLELY ON THE TERMS AND CONDITIONS SET FORTH IN THIS LICENSE AND ON THE CONDITION THAT END USER ACCEPTS AND COMPLIES WITH THEM BY ITS USE OF THE SOFTWARE. END USER (A) ACCEPTS THIS LICENSE AND AGREES THAT END USER IS LEGALLY BOUND BY ITS TERMS; AND (B) REPRESENTS AND WARRANTS: (I) THAT END USER HAS THE RIGHT, POWER, AND AUTHORITY TO ENTER INTO THIS LICENSE AND BE BOUND BY THE TERMS OF THIS LICENSE; AND (II) THAT THE INDIVIDUAL ACCEPTING THIS LICENSE ON BEHALF OF END USER HAS THE PROPER RIGHT AND AUTHORITY TO DO SO. IF END USER DOES NOT AGREE TO THE TERMS OF THIS LICENSE, LICENSOR WILL NOT AND DOES NOT LICENSE THE SOFTWARE TO END USER AND END USER SHALL NOT CONTINUE TO USE THE SOFTWARE OR DOCUMENTATION.

NOTWITHSTANDING ANYTHING TO THE CONTRARY IN THIS LICENSE OR END USER'S ACCEPTANCE OF THE TERMS AND CONDITIONS OF THIS LICENSE, NO LICENSE IS GRANTED (WHETHER EXPRESSLY, BY IMPLICATION, OR OTHERWISE) UNDER THIS LICENSE, AND THIS LICENSE EXPRESSLY EXCLUDES, ANY RIGHT CONCERNING ANY SOFTWARE THAT END USER DID NOT ACQUIRE LAWFULLY OR THAT IS NOT A LEGITIMATE, AUTHORIZED COPY OF LICENSOR'S SOFTWARE.

UNLESS OTHERWISE AGREED TO IN WRITING, END USER AGREES THAT NO TERMS OR CONDITIONS PUT FORWARD BY CUSTOMER'S/END USER'S ORDER OR OTHERWISE, SHALL BE BINDING ON LICENSOR. THE USE OF OWL CYBER DEFENSE SOFTWARE IS EXPRESSLY LIMITED TO THE TERMS OF THIS LICENSE. THE ORDER, AND ANY ADDITIONAL OR DIFFERENT TERMS THAT MAY BE ON AN ORDER ARE OBJECTED TO WITHOUT FURTHER NOTIFICATION BY LICENSOR AND SHALL NOT BE CONSIDERED AS PART OF THIS LICENSE.

NOTE THAT ANY TERMS ON AN ORDER SIMILAR TO "ACCEPTANCE OF PRICE QUOTE ONLY" AND OTHER TERMS INCLUDED IN THE ORDER, IF APPLICABLE TO THIS LICENSE, WILL NOT BE ACCEPTED BY LICENSOR, NOR WILL THE INCLUSION OF THOSE TERMS CONTROL THE USE OF THE LICENSED SOFTWARE UNLESS THERE IS AN ADDENDUM TO THIS LICENSE THAT HAS BEEN EXECUTED BY OWL CYBER DEFENSE IN WRITING.

1. DEFINITIONS. For purposes of this License, the following terms have the following meanings:

- "Affiliates" means, with respect to a Party, any other entity which directly or indirectly controls, is controlled by, or is under common control with such Party. For this purpose, "control" means the possession, directly or indirectly (through one or more intermediaries), of the power to direct or cause the direction of management and policies of any entity through ownership of voting securities, contract, voting trust or otherwise.
- "Customer" means the Person identified as the Customer in the Order Form into which this License is incorporated.
- "<u>Documentation</u>" means user manuals, technical manuals, and any other materials provided by Licensor, in printed, electronic, or other form, that describe the installation, operation, use, maintenance technical specifications or deinstallation of the Software.
- "End User" has the meaning set forth in the preamble.
- "Intellectual Property Rights" means any and all registered and unregistered rights granted, applied for, or otherwise now or hereafter in existence under or related to any patent, copyright, trademark, trade secret, database protection, or other intellectual property rights laws, and all similar or equivalent rights or forms of protection, in any part of the world.
- "<u>Licensed System</u>" means a system on which End User is licensed to install or execute all or a portion of the Software, which may be, without limitation, a server, workstation, embedded system, or other Linux system. If the Software is licensed by Licensed System, the number of Licensed Systems for which End User has licensed the Software shall be set forth in the Order Form.
- "Licensor" has the meaning set forth in the preamble.
- "Order Form" means the quote from Licensor or a purchase order from the Customer with respect to Customer's purchase of the license for the Software (software programs) granted under this License and/or for Customer's purchase of products from Licensor incorporating or requiring associated Software that is licensed under this License.
- "Party" or "Parties" refers to individually the Licensor, Customer, or End User or collectively each and/or two or more of the Parties to this License as appropriate.
- "Person" means an individual, corporation, partnership, joint venture, limited liability company, governmental authority, unincorporated organization, trust, association, or other entity.
- "Software" means the software programs for which Customer is purchasing a license, as expressly set forth in the Order Form, and/or software integrated or embedded in, or required for use with, products which Customer is purchasing from Licensor as expressly set forth in the Order Form (exclusive of Third Party Materials), as well as updates, improvements, modifications, repairs and replacements thereto provided by Licensor under any Technical Services Policy in effect or otherwise in Licensor's sole discretion.
- "Software Product" means the Software, the Software media upon which the Software is provided, and the Documentation.
- "<u>Technical Services Policy</u>" means any Technical Services Policy of Licensor in effect during the term of this License which covers Software support and maintenance services pertaining to the Software licensed under this License.
- "Term" has the meaning set forth in Section 8 of this License.
- "Terms and Conditions" means any Terms and Conditions between Licensor and Customer, into which this License is incorporated.
- "Third Party" means any Person other than Customer, End User or Licensor.

- 2. LICENSE GRANT AND SCOPE. Subject to and conditioned upon End User's strict compliance with all terms and conditions set forth in this License, Licensor hereby grants to End User a non-exclusive, non-transferable, non-sublicensable, limited license during the Term (except as provided in Section 2(d) below) to use the Software and Documentation, solely as set forth in this Section 2 and subject to all conditions and limitations set forth in Section 4 (below) or elsewhere in this License. This License grants End User the right to:
  - (a) Install the Software in accordance with the Documentation and as set forth on the Order Form, including limiting the installation of the Software to that number of Licensed Systems for which End User has licensed the Software and paid the license fees as set forth in the Order Form (regardless of whether the Software is delivered in more than one medium, e.g. as a download, on CD, DVD, USB stick or other storage device). In addition to the foregoing, except as provided in Section 2(d) below, End User has the right to make one copy of the Software solely for archival and back-up purposes, provided that End User shall not, and shall not allow any Person to, install or use any such copy other than if and for so long as any copy installed in accordance with the preceding sentence is inoperable and, provided, further, that End User uninstalls and otherwise deletes such inoperable copy. All copies of the Software made by the End User: (i) will be the exclusive property of the Licensor; (ii) will be subject to the terms and conditions of this License; and (iii) must include all trademark, copyright, patent, and other Intellectual Property Rights notices contained in the original.
  - (b) Use and run the Software as properly installed in accordance with this License and the Documentation, solely as set forth in the Documentation, solely for End User's internal business purposes (except as provided in Section 2(d) below), and solely on that number of Licensed Systems for which End User has licensed the Software and paid the license fees as set forth in the Order Form.
  - (c) Use the Documentation, solely in support of its licensed use of the Software in accordance herewith. All copies of the Documentation made by End User: (i) will be the exclusive property of Licensor; (ii) will be subject to the terms and conditions of this License; and (iii) must include all trademark, copyright, patent, and other Intellectual Property Rights notices contained in the original.
  - (d) If the Software is being provided to End User by Licensor pursuant to a demonstration license ("Demo License") as set forth in a Product Evaluation Agreement between Licensor and End User, all of the terms of this License shall apply to such Software, except that (i) no license fees shall be payable by End User for the Evaluation Period (as such term is defined in the Product Evaluation License), (ii) the End User shall be prohibited from making any copies of the Software; (iii) End User may only use the Software for End User's testing and evaluation of the Software for the purpose of evaluating End User's possible purchase of such Software (or purchase of Licensor's product(s) into which the Software is incorporated), or a possible business relationship between Licensor and End User, as set forth in the Product Evaluation License pursuant to which the Demo License was granted; and (iv) the license grant in this Section 2 will automatically terminate upon expiration of the Evaluation Period (as such term is defined in the Product Evaluation License) if End

User fails to pay all applicable license and product fees prior to such date. Upon payment of all applicable license and product fees, the license grant in this Section 2 shall remain in effect for the Term specified in Section 8 of this License. Notwithstanding the fact that no license fees are payable for the Evaluation Period, End User must limit the installation and use of the Software to that number of Licensed Systems set forth in the Product Evaluation License for the Demo License.

- 3. THIRD-PARTY MATERIALS. The Software may include software, content, data, or other materials, including related documentation, that are owned by Persons other than Licensor (collectively, "Third Party Materials") and that are licensed to Licensor for inclusion with or in the Software provided to End User on license terms that are in addition to and/or different from those contained in this License ("Third-Party Licenses"). A list of materials included with or in the Software and provided under Third-Party Licenses is available upon request. By agreeing to be bound by this License, End User agrees to be bound by and to comply with all applicable Third-Party Licenses. Any breach by End User of any applicable Third-Party License is also a breach of this License.
- 4. USE RESTRICTIONS. End User shall not, directly, or indirectly:
  - (a) install or use (including make any copies of) the Software or Documentation beyond the scope of the license granted under Section 2;
  - (b) provide any other Person with access to or use of the Software or Documentation, except for independent contractors, which may include subcontractors or contract labor, consultants, service providers or other agents (collectively "Representatives") who have a need to access and use the Software solely for End User's internal business purposes and who are aware of and agree to abide by all of the terms of this License;
  - (c) modify, translate, adapt, or otherwise create derivative works or improvements, whether or not patentable, of the Software or Documentation or any part thereof;
  - (d) make, have made, sell, offer for sale, reproduce (except that a copy of the Software may be made for archive purposes), display, perform, distribute (internally or externally) copies of, or transfer computer the software, nor may the End User authorize others to do any, some, or all of the foregoing;
  - (e) combine the Software or any part thereof with, or incorporate the Software or any part thereof in, any other programs;
  - (f) reverse engineer, disassemble (the foregoing prohibition includes review of data structures or similar materials produced by the Software), decompile, decode, translate, or otherwise attempt to derive or gain access to the source code of the Software or any part thereof;

- (g) remove, delete, alter, or obscure any trademarks or any copyright, trademark, patent, or other intellectual property or proprietary rights notices provided on or with the Software or Documentation, including any copy thereof;
- (h) copy the Software or Documentation, in whole or in part, except as permitted in Section 2(a) above;
- (i) except as set forth in Section 4(b) above, rent, lease, lend, sell, offer to sell, sublicense, assign, distribute, publish, transfer, or otherwise make available the Software, or any features or functionality of the Software, to any Third Party for any reason, whether or not over a network or on a hosted basis, including in connection with the internet or any web hosting, wide area network (WAN), virtual private network (VPN), virtualization, timesharing, service bureau, software as a service, cloud, or other technology or service;
- (j) use the Software or Documentation in violation of any law, regulation, or rule;
- (k) use the Software or Documentation for purposes of competitive analysis of the Software, the development of a competing software product or service, or any other purpose that is to the Licensor's commercial disadvantage; or
- (1) publish the results of any benchmark tests run on the Software.
- 5. RESPONSIBILITY FOR USE OF SOFTWARE. End User is responsible and liable for all uses of the Software and Documentation through access thereto provided by End User, directly or indirectly. Specifically, and without limiting the generality of the foregoing, End User is responsible and liable to Licensor for any breach or violation of this License by Representatives and for all actions and failures to take required actions with respect to the Software and Documentation, including without limitation actions and failures to take required action by any other Person to whom End User may provide access to or use of the Software and/or Documentation, whether such access or use is permitted by or in violation of this License.
- 6. COMPLIANCE MEASURES. The Software may contain technological copy protection or other security features designed to prevent unauthorized use of the Software, including features to protect against any use of the Software that is prohibited under Section 4 (above). End User shall not, and shall not attempt to, remove, disable, circumvent, or otherwise create or implement any workaround to, any such copy protection or security features.
- 7. INTELLECTUAL PROPERTY RIGHTS. End User acknowledges and agrees that the Software and Documentation are provided under license, and not sold, to End User. End User does not acquire any ownership interest in the Software or Documentation under this License, or any other rights thereto, other than to use the same in accordance with the license granted and subject to all terms, conditions, and restrictions under this License. Licensor and its licensors and service providers reserve and shall retain their entire right, title, and interest in and to the Software, the Documentation and all Intellectual Property Rights arising out of or relating to the Software and Documentation, except as expressly granted to the End User in this License. End User shall safeguard all Software and Documentation (including all copies thereof) from infringement,

misappropriation, theft, misuse, or unauthorized access. End User shall promptly notify Licensor if End User becomes aware of any infringement or violation of the Licensor's Intellectual Property Rights in the Software or Documentation and will fully cooperate with Licensor in any legal action taken by Licensor to enforce its Intellectual Property Rights.

#### 8. SOFTWARE TERM AND TERMINATION.

- (a) Except as provided in Section 13 (below) Reseller and/or Integrator, this License will commence when the Software is installed, and the End User starts using the Software. Except for any Demo License which shall terminate as provided in Section 2(d), this License and the license granted hereunder shall remain in effect in perpetuity unless earlier terminated as set forth herein (the "Software Term").
- (b) End User may terminate this License by ceasing to use and destroying all copies of the Software Product.
- (c) Licensor may terminate this License, effective upon written notice to End User, if End User materially breaches this License and such breach: (i) is incapable of cure; or (ii) being capable or cure, remains uncured ten (10) calendar days after Licensor provides written notice thereof.
- (d) Upon termination of this License, the license granted hereunder shall also terminate, and End User shall cease using and destroy all copies of the Software Product, and End User shall certify same in writing to Licensor upon Licensor's request. No termination shall affect End User's obligation to pay all fees that may have become due before such termination or entitle End User to any refund.

## 9. WARRANTY.

- (a) Licensor warrants that the Software media will be free from defects in material and workmanship for a period of one (1) month from the scheduled delivery date ("Warranty Period"), Seller will replace the Software media, which fails under normal use as a result of a defect in material or workmanship.
- (b) This warranty does not include damage to the Software media resulting from: accident; or misuse; improper installation or operation; or violation of this License; unauthorized or improper repair, replacement or alteration (including, but not limited to, repairs, replacements, or alterations made or performed by someone other than Licensor's employees or authorized representatives); unreasonable use or abuse of the Software media; or failure to follow written installation or operating instructions.
- (c) TO THE MAXIMUM EXTENT PERMITTED UNDER APPLICABLE LAW, LICENSOR, ON ITS OWN BEHALF AND ON BEHALF OF ITS AFFILIATES AND ITS AND THEIR RESPECTIVE LICENSORS AND RESELLERS, EXPRESSLY DISCLAIMS ALL OTHER WARRANTIES, WHETHER EXPRESS, IMPLIED, STATUTORY, OR OTHERWISE, WITH RESPECT TO THE SOFTWARE PRODUCT, INCLUDING ALL IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS

FOR A PARTICULAR PURPOSE, TITLE, AND NONINFRINGEMENT, AND WARRANTIES THAT MAY ARISE OUT OF COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE, OR TRADE PRACTICE. WITHOUT LIMITATION TO THE FOREGOING, THE LICENSOR PROVIDES NO WARRANTY OR UNDERTAKING, AND MAKES NO REPRESENTATION OF ANY KIND THAT THE SOFTWARE PRODUCT WILL MEET THE **END** REOUIREMENTS, ACHIEVE ANY INTENDED RESULTS, BE COMPATIBLE OR WORK WITH ANY OTHER SOFTWARE, APPLICATIONS, HARDWARE, SYSTEMS, OR SERVICES, OPERATE UNINTERRUPTED OR ERROR-FREE, MEET ANY PERFORMANCE OR RELIABILITY STANDARDS, BE FREE VULNERABILITY TO INTRUSION OR ATTACK, OR THAT ANY ERRORS OR DEFECTS CAN OR WILL BE CORRECTED. LICENSOR SHALL HAVE NO LIABILITY FOR ANY CLAIMED NON-CONFORMANCE OF THE SOFTWARE PRODUCT UNDER ARTICLE 35(2) OF THE UNITED NATIONS CONVENTION ON CONTRACTS FOR THE INTERNATIONAL SALE OF GOODS, EVEN IF SUCH CONVENTION IS FOUND TO BE APPLICABLE TO THIS LICENSE, THE SOFTWARE OR THE TRANSACTIONS HEREUNDER. LICENSOR ALSO STRICTLY DISCLAIMS ALL WARRANTIES WITH RESPECT TO ANY THIRD-PARTY MATERIALS. LICENSOR ASSIGNS TO END USER ALL WARRANTIES PROVIDED BY THE OWNERS OR LICENSORS OF ANY THIRD-PARTY MATERIALS TO THE EXTENT THEY ARE ASSIGNABLE.

- (d) THE WARRANTIES IN THIS SECTION 9. ARE THE SOLE AND EXCLUSIVE WARRANTIES PROVIDED FOR THE SOFTWARE PRODUCT UNDER THIS LICENSE.
- 10. LIMITATION OF LIABILITY. TO THE FULLEST EXTENT PERMITTED UNDER APPLICABLE LAW:
  - (a) IN NO EVENT WILL LICENSOR OR ITS AFFILIATES, OR ANY OF ITS OR THEIR RESPECTIVE LICENSORS OR RESELLERS. BE LIABLE TO END USER OR ANY THIRD PARTY FOR ANY USE, INTERRUPTION, DELAY, OR INABILITY TO USE THE SOFTWARE PRODUCT; LOST REVENUES OR PROFITS; DELAYS, INTERRUPTION, OR LOSS OF SERVICES, BUSINESS, OR GOODWILL: LOSS OR CORRUPTION OF DATA; LOSS RESULTING FROM SYSTEM OR SYSTEM SERVICE FAILURE. MALFUNCTION. OR SHUTDOWN: FAILURE ACCURATELY TRANSFER, READ, OR TRANSMIT INFORMATION; FAILURE TO UPDATE OR PROVIDE CORRECT INFORMATION; SYSTEM INCOMPATIBILITY OR PROVISION OF INCORRECT COMPATIBILITY INFORMATION; OR BREACHES IN SYSTEM SECURITY; OR FOR ANY CONSEQUENTIAL, INCIDENTAL, INDIRECT, EXEMPLARY, SPECIAL, OR PUNITIVE DAMAGES, WHETHER ARISING OUT OF OR IN CONNECTION WITH THIS LICENSE, BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), OR OTHERWISE, REGARDLESS OF WHETHER SUCH DAMAGES WERE FORESEEABLE AND WHETHER OR NOT THE LICENSOR WAS ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.

- (b) IN NO EVENT WILL LICENSOR'S, ITS AFFILIATES', AND THEIR RESPECTIVE LICENSORS' AND RESELLERS', COLLECTIVE AGGREGATE LIABILITY UNDER OR IN CONNECTION WITH THIS LICENSE OR ITS SUBJECT MATTER UNDER ANY LEGAL OR EQUITABLE THEORY, INCLUDING BREACH OF CONTRACT, TORT (INCLUDING NEGLIGENCE), STRICT LIABILITY, AND OTHERWISE, EXCEED THE TOTAL AMOUNT PAID BY OR ON BEHALF OF END USER TO THE LICENSOR FOR THE LICENSE OF THE SOFTWARE IN THE TWELVE (12) MONTH PERIOD PRECEDING THE EVENT WHICH GAVE RISE TO THE CLAIM, OR \$1,000, WHICHEVER IS LESSER. THIS LIMITATION OF LIABILITY FOR SOFTWARE IS CUMULATIVE AND NOT PER INCIDENT (I.E., THE EXISTENCE OF TWO OR MORE CLAIMS WILL NOT ENLARGE THIS LIMIT).
- (c) THE LIMITATIONS SET FORTH IN SECTIONS 10(a) AND 10(b) SHALL APPLY EVEN IF END USER'S REMEDIES UNDER THIS LICENSE FAIL OF THEIR ESSENTIAL PURPOSE.
- 11. EXPORT REGULATION. The Software Product may be subject to US export control laws, including the United States International Traffic in Arms Regulations ("ITAR") and the United States Export Administration Regulations ("EAR"). End User shall not, directly or indirectly, export, re-export, or release the Software or Documentation to, or make the Software or Documentation accessible from, any jurisdiction or country to which export, re-export, or release is prohibited by law, rule, or regulation. End User shall comply with all applicable federal laws, regulations, and rules, and complete all required undertakings (including obtaining any necessary export license or other governmental approval), prior to exporting, re-exporting, releasing, or otherwise making the Software or Documentation available outside the United States.

Without limiting the generality of the foregoing, End User agrees that all of the following are, and will remain, true during the Term of this License: (i) End User is not a citizen, national, or resident of, and is not under control of, the government of any country to which the United States has prohibited export; (ii) End User will not download or otherwise export or re-export the Software, directly or indirectly, to any such prohibited country nor to citizens, nationals, or residents of any such country; (iii) End User is not listed on the United States Department of Treasury lists of Specially Designated Nationals, Specially Designated Terrorists, and Specially Designated Narcotic Traffickers, nor is End User listed on the United States Department of Commerce Table of Denial Orders; (iv) End User will not download or otherwise export or reexport the Software, directly or indirectly, to Persons on the above mentioned lists; and (v) End User will not use the Software for, and will not allow the Software to be used for, any purposes prohibited by United States law, including, without limitation, for the development, design, manufacture or production of nuclear, chemical, or biological weapons of mass destruction.

12. US GOVERNMENT RIGHTS. The Software is "Commercial Computer Software" and the Documentation is "Commercial Products" as those terms are defined in 48 C.F.R. §2.101, within the meaning of 48 C.F.R. 12.212 or 48 C.F.R. 227.7202, as applicable. Accordingly, if End User is the United States Government, End User shall receive only those rights with respect to the Software and Documentation as are granted to all other end users under license, as set forth herein,

in accordance with (a) 48 C.F.R.§2.101 and §12.212, with respect to all other US Government licensees and their contractors, or (b) 48 C.F.R. §227.7201 through 48 C.F.R. §227.7202-4 with respect to the Department of Defense and their contractors. Additional terms and conditions that apply solely to the United States Government are provided in the "Government Addendum" attached hereto as applicable.

13. RESELLERS AND/OR INTEGRATORS. If the Customer is a Reseller, Integrator or other organization that has been authorized by Owl Cyber Defense to purchase the Software (hereinafter "Customer Reseller") and the Software will not be sent directly to the End User, but instead to the Customer Reseller, then unless otherwise provided in writing by Owl Cyber Defense, the Warranty will commence upon the Warranty start date (defined in Section 9), regardless of when the End User receives the Software Product. Notwithstanding the foregoing, if a Customer Reseller purchases inventory, then the Warranty shall commence upon notification by the Customer Reseller that it has sold the Software Product. In any instance where Owl Cyber Defense does not ship to the End User, the Customer Reseller shall send the attached Notice of Software Product Transfer to Owl Cyber Defense.

### 14. INDEMNIFICATION.

- (a) In the event that a suit or action for alleged intellectual property infringement arising from the sale or use of the Software Product is brought against Customer or End User, and to the extent such third party claim is not covered by Section 14.(b) below and does not relate to a breach of this License by Customer or End User, Owl Cyber Defense shall defend and indemnify Customer or End User for such dispute, provided that: (i) the claim of infringement is solely based on the sale or use of the Software Product; (ii) Customer or End User shall have given Owl Cyber Defense timely written notice of such infringement claim and provide reasonable cooperation, information and assistance in connection therewith; and (iii) Owl Cyber Defense shall have sole control and authority with respect to defense or settlement thereof. Should any Software Product become, or in Owl Cyber Defense's sole opinion be likely to become, the subject of such a claim, Owl may, at its sole option and discretion: (i) eliminate such infringement by procuring for Customer or End User the right to continue using any such Software Products; (ii), replace or modify any such Software Products so that they become non-infringing; or (iii) refund to Customer or End User the pro-rata purchase price paid for such Software Product. The purchase price upon which the pro-rata purchase price is calculated is defined as the price paid for the Software Product in the twelve (12) month period prior to such refund.
- (b) Notwithstanding the foregoing, Owl Cyber Defense shall have no liability or obligations to Customer or End User hereunder with respect to any intellectual property infringement or claim thereof based upon (i) use of the Software Product or any part thereof in combination with devices or products not purchased from Owl Cyber Defense where the use of the Software Products alone would not be infringing; (ii) use of the Software Products in a manner inconsistent with the Documentation or in an application or environment for which such Software Products were not designed or contemplated; (iii) modification of the Software Products; (iv) any claim of infringement of a patent based on use of Software Products purchased from Licensor in which the Customer or End User or any of its Affiliates has an interest in or license to that patent; or (v) any time period after

a notification to the Customer or End User by Owl Cyber Defense that Customer or End User must stop using the Software Products purchased hereunder due to the possibility of infringement. Section 14.(a) states the entire liability of Owl Cyber Defense with respect to infringement of intellectual property by the Software Products or any part thereof.

#### 15. MISCELLANEOUS.

- (a) All matters arising out of or relating to this License shall be governed by and construed in accordance with the internal laws of the Commonwealth of Virginia without giving effect to any choice or conflict of law provision or rule. Any legal suit, action, or proceeding arising out of or relating to this License or the transactions contemplated hereby shall be instituted exclusively in the United States District Court for the Eastern District of Virginia or in the state courts located in Fairfax, Virginia, and Licensor, Customer and End User irrevocably submit to the exclusive jurisdiction of such courts in any such legal suit, action, or proceeding. Notwithstanding the foregoing, Licensor may bring an action for equitable relief in any court of competent jurisdiction. CUSTOMER, END USER AND LICENSOR WAIVE ANY RIGHT THEY MAY HAVE TO A TRIAL BY JURY IN ANY SUIT, ACTION OR PROCEEDING ARISING OUT OF OR RELATING TO THIS LICENSE OR THE TRANSACTIONS DESCRIBED HEREIN. Customer and End User expressly disclaim the applicability of, and waive any rights based upon, the Uniform Computer Information Transactions Act or the United Nations Convention on Contracts for the International Sale of Goods. Service of process, summons, notice, or other document by mail to such Party's address set forth in the Order Form shall be effective service of process for any suit, action, or other proceeding brought in any such court.
- (b) Licensor will not be responsible or liable to End User, or deemed in default or breach hereunder, by reason of any failure or delay in the performance of its obligations hereunder where such failure or delay is due to strikes, labor disputes, civil disturbances, riot, rebellion, invasion, epidemic, pandemic, hostilities, casualty, war, terrorist attack, embargo, natural disaster, acts of God, flood, fire, sabotage, fluctuations or non-availability of electrical power, heat, light, air conditioning, the Internet, materials or End User equipment, loss and destruction of property, government regulations or controls, government emergency declarations, government authority, government shutdowns or any other circumstances or causes beyond Licensor's reasonable control.

- (e) Without the prior written consent of Licensor, End User shall not assign or otherwise transfer any of its rights, or delegate or otherwise transfer any of its obligations or performance, under this License, except to a successor to all or substantially all of its business and assets who assumes in writing all of End User's obligations under this License. End User must provide written notice to Licensor of any such assignment and of the assignee/successor's written assumption of End User's obligations hereunder within ten (10) days of the effective date of such assignment. No assignment, delegation or other transfer will relieve End User of any of its obligations or performance under this License. Any purported assignment, delegation, or transfer in violation of this Section 15(e) is void. Licensor may freely assign or otherwise transfer all or any of its rights, or delegate or otherwise transfer all or any of its obligations or performance, under this License without End User's consent. Notwithstanding the foregoing, Licensor may amend this License from time to time by written notice to End User in connection with any update to the Software, and End User's acquisition and use of such updated Software will constitute End User's acceptance of such amended License; provided, however, that the foregoing does not affect End User's right to continue to use any version of the Software to which this License applies in lieu of using an updated version which is subject to any amendment to this License. No waiver by any Party of any of the provisions hereof shall be effective unless explicitly set forth in writing and signed by the Party so waiving. Except as otherwise set forth in this License, no failure to exercise, or delay in exercising, any right, remedy, power, or privilege arising from this License shall operate or be construed as a waiver thereof; nor shall any single or partial exercise of any right, remedy, power, or privilege hereunder preclude any other or further exercise thereof or the exercise of any other right, remedy, power or privilege.
